Aim of the *M*-EPLI Round Table

M-EPLI's round table meetings are small-scale conferences devoted to a single theme. It offers the opportunity for experts from across the world to debate issues of European Private Law with the *M*-EPLI fellows and others who are interested. *M*-EPLI Round table meetings take the form of presentations, followed by comments as a start-off for the debate.

M-EPLI Round Table on the Functional Method in Property Law

Increasingly property lawyers receive criticism on their use of the functional comparative method. Different from other areas of private law, there are traditionally large divergences between the property laws of the EU Member States. Comparative and European property lawyers often seek to explain these differences on the basis of a legal-historical analysis before moving to a comparison on basis of functional equivalents. However, there is an increasing awareness of the sensitivities involved in using such a method, which often leads to a simplification of legal systems in order to align them for comparison.

This *M*-EPLI Round-Table is devoted to exactly this problem of how to compare jurisdictions that show wide divergences. In this sense, property law is seen as one example of where this is the case: the seminar will also be interesting for comparatists working in other fields. At the meeting, emphasis is put not so much on theories of comparative law, but rather on how to go about comparing in the daily practice of comparative work.

Prof. dr. Jaakko Husa holds the Chair of Legal Culture and Legal Linguistics at Lapland University (Finland) and is an adjunct professor of Comparative Legal Science at the University of Helsinki.

Prof. dr. Arthur Salomons is professor of Private Law at the Centre for the Study of European Contract Law of the Law Faculty of the University of Amsterdam, the Netherlands. Moreover, he is a deputy justice in the Court of Appeal of Amsterdam in the Netherlands. His research interest focuses on (European) Property Law.

Prof. dr. Jan Smits holds the Chair of European Private Law at Maastricht University and is a visiting professor of Comparative Legal studies in the University of Helsinki. He is academic director of *M*-EPLI.
