The results of the workshop have now been presented to the Executive Committee and the intended use of the Climate Action fund for 2025 has been decided. As worked out in the workshop, the resources from the CO2 levy in the Climate Action fund for 2025 are to be channelled into the area of everyday mobility, particularly the promotion of bicycle mobility. Following the presentation in the Senate, the use of the Climate Action fund has now also been made transparent on the Climate Action fund website.

For the first time this year, the programme has been expanded to include a flea market, where (international) students and employees can register for a stall to get rid of things they have discarded.
